Background

EvaluATE harnesses the evaluation expertise of the ATE community to achieve its mission "to strengthen the program's evaluation knowledge base, expand the use of exemplary evaluation practices, and support the continuous improvement of technician education throughout the nation."

Because EvaluATE is involved in advancing evaluation practice, the project is intimately involved in the evaluation of its own work, but also recognizes the necessity and value of working with an external evaluator. As such, The Rucks Group has been working with EvaluATE since 2012 and has conducted a survey among EvaluATE's stakeholders every two years from 2012 to 2020. The survey is specifically designed to capture data related to the following set of evaluation questions¹ which provide a framework for the external evaluation efforts:

- 1. To what extent has EvaluATE engaged its intended and other audiences? (Engagement)
- 2. To what extent are EvaluATE's users satisfied with EvaluATE's activities and resources? (Satisfaction)
- 3. To what extent has EvaluATE's work led to improvements in users' knowledge of and attitudes toward evaluation? (Learning)
- 4. To what extent has EvaluATE's work prompted users to (a) modify their evaluation practices and (b) extend their network of evaluation colleagues? (Application)
- 5. To what extent has EvaluATE contributed to improvements in evaluation quality? (Impact)

This summary report presents the descriptive results from the 2020 administration of the external evaluation survey. The findings will be reviewed with EvaluATE as they relate to the above research questions and will serve as a basis for discussing potential changes to EvaluATE's activities and efforts moving forward.

Survey and Data Collection

The 2020 external evaluation survey instrument included items to capture the following: demographic information regarding the respondents (e.g., employment area and role on ATE project); respondents' use and opinions of EvaluATE's resources; what they have learned from EvaluATE; actions they attribute to information received from EvaluATE; and EvaluATE's influence on the quality of their evaluations. The 2020 questionnaire included some minor revisions to the 2018 version. A copy of the survey items is provided in Appendix A.

The Rucks Group administered a web-based survey over three weeks starting September 30, 2020. Survey recipients included individuals in EvaluATE's contact database who - at some point over the prior four years – had been associated with an active ATE grant or had attended an EvaluATE workshop or webinar. Each of these 3,326 individuals received a survey invitation that included the survey link, a brief description of the

¹ The overall external evaluation effort includes a sixth question, "How is EvaluATE influencing the program's overall evaluation capacity?" as indicated by changes in organizational processes and practices related to evaluation and the diffusion and uptake of EvaluATE's research findings. These indicators are not captured through the external evaluation survey and are being assessed through other means.

survey's purpose, assurances of confidentiality, and notification that no personally identifiable information will be shared with EvaluATE personnel.

Response rate

The figure below shows the total number of individuals who responded to the survey split by ATE involvement. It also shows the number of respondents who were routed out of the survey because they responded "no" or "unsure" to the question "Have you ever visited EvaluATE's website or sought out information from EvaluATE?" This item was included to reduce subsequent item non-response rates.²




Figure 1. Shows the total number of individuals who responded to the survey split by ATE participation and the number from each group who were routed-out of the survey because they had never visited EvaluATE's website or sought information from EvaluATE at any point.

² Respondents in prior years had written comments indicating that they could not recall ever using EvaluATE or did not know why they had been asked to participate and then skipped questions or quit the survey. It is possible that some individuals have been mistakenly included on the initial list or might not remember participating in an EvaluATE event, particularly if their participation was several years prior.

66% of respondents are involved in an ATE project or proposal in some way




Figure 2. Percentage of respondents who reported being involved in an ATE project or proposal. (n=262)

Findings

This section provides the descriptive statistics from the questions asked of the 263 respondents who visited EvaluATE at some point. Several of the questions, however, asked the respondent to provide ratings regarding the specific impact that EvaluATE has had in terms of participants' actions and professional development. These questions were only asked of the respondents who had accessed EvaluATE's resources at least once in the prior year.

Overall quality of EvaluATE's resources






Figure 3. Frequency of responses the question, "Rate the overall quality of the information you have obtained from EvaluATE." (n=263)

All external evaluation survey respondents were asked to rate the overall quality of the information they have obtained from EvaluATE. Most respondents gave ratings of "very good" or "excellent", with ATE respondents providing slightly more positive ratings than non-ATE respondents as shown in Figure 3.

Eighty-four percent of all respondents rated the overall quality of quality of EvaluATE's information as "excellent" or "very good."





Figure 5. Frequency of responses the question, "How useful has each of the following EvaluATE resources been for you?








Figure 7. Frequency of responses the question, "How much influence did information obtained from EvaluATE have on your decision to do these things?"

EvaluATE's biggest impact on improving respondents' evaluation skills or practices

The external evaluation survey included an open-ended question asking respondents to describe the information, resources, or guidance that has had the biggest impact on improving their evaluation skills or practices. One hundred sixty-five (63%) responded to this question. Some respondents made general statements regarding the provision of resources that are helpful including materials, templates, handouts, and examples. Many, however, mentioned specific resources and topics that have been particularly helpful. The most frequently mentioned themes and topics along with corresponding illustrative quotes are provided in the table below. The full set of responses and corresponding themes are included in Appendix B.

What EvaluATE is doing particularly well

The external evaluation survey also included an open-ended question asking respondents to describe the one or two things EvaluATE is doing particularly well. One hundred eighty-nine (72%) of the 263 respondents identified at least one thing. Strengths related to the guidance that EvaluATE provides through webinars, training sessions, and presentations at conferences conference presentations were the most commonly mentioned. This was followed closely by comments related to the quality of the resources and tools that EvaluATE shares through direct communications with EvaluATE's stakeholders and on its website. Many respondents provided comments related to the clarity, consistency, and timeliness of communications coming from EvaluATE as well as the opportunities offered to network and connect with others in the EvaluATE community through chats, webinars, conference events. All responses to this question and corresponding themes are provided in Appendix C.

How EvaluATE could improve its work or increase its impact

The external evaluation survey also included an open-ended question asking respondents to provide one or two suggestions regarding how EvaluATE could most improve their work or increase their impact. Seventy (27%) respondents offered at least one substantive suggestion while 25 (10%) replied that EvaluATE should just continue to do what they are doing. The remaining respondents either skipped the question or said that they had no suggestions/were unsure. The table below provides the five themes mentioned most by respondents. The full list of responses can be found in Appendix D including specific suggestions that might be very useful to EvaluATE.

Different tiers of offerings/resources -From eval users to experienced evaluators (12)	Provide advanced training in evaluation. One of the biggest challenges EvaluATE has faced in making its training useful is trying to meet the needs of all the audience members at once: PIs with little exposure to evaluation, early-career evaluators, and experienced evaluators. I wish that support was provided separately for each of these audiences.
Better promotion/marketing/ more notifications (12)	Spread information to colleges and institutions that are offering evaluation programs so the information is shared with students.
Facilitate more networking/discussion/ sharing opportunities (11)	I think opportunities to directly engage in more interactive forums. For instance, if there was opportunity to submit a problem or issue one is facing in the evaluation process and to have a forum around it. Or provide space for online community support around evaluation questions. Where others can directly engage one another as well as EvaluATE staff.
Expand reach beyond NSF/ATE (4)	More outreach to non-NSF funded organizations would be appreciated. Although my organization is not NSF-funded we find EvaluATE's information and resources to be immensely useful. We want to make sure you know we're out there; we appreciate you and would love more info and resources!

Summary

The findings cited in this initial report provide credible evidence towards answering each of the evaluation questions as described below

1. To what extent has EvaluATE engaged its intended and other audiences?

The findings from the external evaluation survey suggests that EvaluATE is continuing to reach its intended audience of ATE PIs, Co-PIs, and evaluators, as well as a broader audience both within and outside the ATE community. In addition, most of those who use EvaluATE's resources are sharing the information with others which continues to expand EvaluATE's reach.

2. To what extent are EvaluATE's users satisfied with EvaluATE's activities and resources?

Most users rated the quality of EvaluATE's resources very highly. In addition, both the quantitative and qualitative results indicate that users continue to find EvaluATE's webinars and resources (e.g., checklists and templates) to be particularly useful.

3. To what extent has EvaluATE's work led to improvements in users' knowledge of and attitudes toward evaluation?

The findings also provide evidence that EvaluATE's resources are enhancing users' evaluation knowledge particularly regarding what the NSF's expectations are regarding evaluation and what should be included in the evaluation plan.

4. To what extent has EvaluATE's work prompted users to (a) modify their evaluation practices and (b) extend their network of evaluation colleagues?

Many of the EvaluATE users, particularly those who are involved in ATE projects, reported that the support and resources provided by EvaluATE had a strong influence on them in terms of engaging in various behaviors related to good evaluation practice including integrating evaluation more effectively into their projects and expanding their networks colleagues who practice evaluation.

5. To what extent has EvaluATE contributed to improvements in evaluation quality?

Many users from the ATE community reported that EvaluATE's resources and guidance had greatly improved aspects of their evaluation practice, particularly with regards to evaluation plans, evaluation reports, and the use of logic models.

It should be noted that the external evaluators will integrate findings from this survey with findings from other external and internal evaluation data gathering efforts. Taken together, these will be reviewed and discussed with the project team to identify EvaluATE's current strengths, opportunities for improvement, and possible directions moving forward.
